

**Can I make partial tax payments
on delinquent taxes? Yes!**

You can pay any amount at any time or contact us to set up a payment plan that fits your budget:

Partial payments for **late payment of delinquent taxes** are accepted at any office of the St. Louis County Department of Revenue and by mail. Payments will first be applied to unpaid fees, interest and penalties, and then to the unpaid balance of the tax amount. Late charges will continue to accrue on the unpaid balance up to 18% interest per year, plus a 2% penalty (statutorily set).

If you make partial payments, you will receive a receipt for the amount paid for your records, but **your tax bill will not be marked “paid” until it is paid in full.** This is important to remember if a personal property receipt is needed for license plate renewal.

Important:

Partial payments do not prevent future collection efforts such as selling real estate in a tax sale or filing suit to collect personal property taxes.

Tax Pre-Payment Program

Enroll in the no-cost program to pre-pay your current real and/or personal property taxes.

Here is how it works:



- Taxes must be current
- Your pre-payment amount is determined by taking last year's tax amount and dividing it into four equal amounts.
- The last payment is adjusted to this year's actual tax amount.
- You will receive statements for quarterly payments.
- Payments are due on or before
 - ◇ March 31
 - ◇ June 30
 - ◇ August 31
 - ◇ December 31 (the finalized tax bill will be mailed in November)
- Pre-paid amounts do not earn interest
- No need to re-apply every year
- **Pre-payments can be made via mail or in Clayton ONLY** and cannot be accepted at the satellite offices or online.
